- Four counts of Rape (F1)
- One count of Sexual Battery (F3)
- One count of Corrupting Another with Drugs (F2)
- One count of Aggravated Possession of Drugs (F5)
- Two counts of Vandalism (F5)

Copies of the indictments are attached. A warrant was issued and the Defendant has been arrested. The cases have been assigned to Judge Michael A. Buckwalter.

COUNT 1: MICHAEL M. GENTILE, on or about May 22, 2017, in Greene County, Ohio, or by some manner enumerated in Section 2901.12 of the Ohio Revised Code whereby proper venue is placed in Greene County, Ohio, did, engage in sexual conduct with another who is not the spouse of the offender or who is the spouse of the offender but is living separate and apart from the offender and the said MICHAEL M. GENTILE for the purpose of preventing resistance, did, substantially impair the victim's judgment or control by administering any drug, intoxicant, or controlled substance to the other person surreptitiously or by force, threat of force, or deception, contrary to and in violation of Section 2907.02(A)(1)(a) of the Ohio Revised Code and against the peace and dignity of the State of Ohio. (Rape, a felony of the first degree)

COUNT 2: MICHAEL M. GENTILE, on or about May 22, 2017, in Greene County, Ohio, or by some manner enumerated in Section 2901.12 of the Ohio Revised Code whereby proper venue is placed in Greene County, Ohio, did, engage in sexual conduct with another who is not the spouse of the offender or who is the spouse of the offender but is living separate and apart from the offender and the said MICHAEL M. GENTILE for the purpose of preventing resistance, did, substantially impair the victim's judgment or control by administering any drug, intoxicant, or controlled substance to the other person surreptitiously or by force, threat of force, or deception, contrary to and in violation of Section 2907.02(A)(1)(a) of the Ohio Revised Code and against the peace and dignity of the State of Ohio. (Rape, a felony of the first degree)

COUNT 3: MICHAEL M. GENTILE, on or about May 22, 2017, in Greene County, Ohio, or by some manner enumerated in Section 2901.12 of the Ohio Revised Code whereby proper venue is placed in Greene County, Ohio, did, engage in sexual conduct with another who is not the spouse of the offender or who is the spouse of the offender but is living separate and apart from the offender, and the other person's ability to resist or consent was substantially impaired because of a mental or physical condition, and the offender knew or had reasonable cause to believe that the other person's ability to resist or consent was substantially impaired because of a mental or physical condition, contrary to and in violation of Section 2907.02(A)(1)(c) of the Ohio Revised Code and against the peace and dignity of the State of Ohio. **(Rape, a felony of the first degree)**


COUNT 4: MICHAEL M. GENTILE, on or about May 22, 2017, in Greene County, Ohio, or by some manner enumerated in Section 2901.12 of the Ohio Revised Code whereby proper venue is placed in Greene County, Ohio, did, engage in sexual conduct with another who is not the spouse of the offender or who is the spouse of the offender but is living separate and apart from the offender, and the other person's ability to resist or consent was substantially impaired because of a mental or physical condition, and the offender knew or had reasonable cause to believe that the other person's ability to resist or consent was substantially impaired because of a mental or physical condition, contrary to and in violation of Section 2907.02(A)(1)(c) of the Ohio Revised Code and against the peace and dignity of the State of Ohio. **(Rape, a felony of the first degree)**


COUNT 5: MICHAEL M. GENTILE, on or about May 22, 2017, in Greene County, Ohio, or by some manner enumerated in Section 2901.12 of the Ohio Revised Code whereby proper venue is placed in Greene County, Ohio, did, engage in sexual conduct with another, not the spouse of the offender, when the offender knew that the other person's ability to appraise the nature of or control the other person's own conduct was substantially impaired, contrary to and in violation of Section 2907.03(A)(2) of the Ohio Revised Code and against the peace and dignity of the State of Ohio. **(Sexual Battery, a felony of the third degree)**

COUNT 6: MICHAEL M. GENTILE, on or about May 22, 2017, in Greene County, Ohio, or by some manner enumerated in Section 2901.12 of the Ohio Revised Code whereby proper venue is placed in Greene County, Ohio, did, have sexual contact with another, not the spouse of the offender; and the ability of the other person to resist or consent is substantially impaired because of a mental or physical condition, and the offender knew or had reasonable cause to believe the ability to resist or consent of the other person was substantially impaired because of a mental or physical condition, contrary to and in violation of Section 2907.05(A)(5) of the Ohio Revised Code, and against the peace and dignity of the State of Ohio. **(Gross Sexual Imposition, a felony of the fourth degree)**

COUNT 7: MICHAEL M. GENTILE, on or about May 22, 2017, in Greene County, Ohio, or by some manner enumerated in Section 2901.12 of the Ohio Revised Code whereby proper venue is placed in Greene County, Ohio, did, knowingly, by any means, furnish or administer a controlled substance to a juvenile who is at least two years the offender's junior, when the offender knew the age of the juvenile or was reckless in that regard, contrary to and in violation of Section 2925.02(A)(4)(a) of the Ohio Revised Code and against the peace and dignity of the State of Ohio. **(Corrupting Another with Drugs, a felony of the second degree, with mandatory imprisonment)**

COUNT 8: MICHAEL M. GENTILE, on or about May 22, 2017, in Greene County, Ohio, or by some manner enumerated in Section 2901.12 of the Ohio Revised Code whereby proper venue is placed in Greene County, Ohio, did, knowingly obtain, possess or use a controlled substance or a controlled substance analog, to wit: Oxycontin, a Schedule II drug, as described in the laboratory report, incorporated herein by reference, in an amount less than the bulk amount, contrary to and in violation of Section 2925.11(A) of the Ohio Revised Code and against the peace and dignity of the State of Ohio. **(Aggravated Possession of Drugs, a felony of the fifth degree)**


