

Charter Amendment - Revise Section 2.02 to modify the Mayor's term from two years to four years & Revise Section 2.03 to modify consecutive terms for council and mayor so they may serve a maximum of two consecutive four-year terms in each office before a two-year break is required. Revise Section 2.12 to add the phrase "any other reason consistent with the Ohio Revised Code" to the reasons the Fairborn City Council may recess into executive session & Revise Section 2.15 to remove language that automatically repeals emergency ordinances 180 days after their adoption. Revise Section 7.02 (a) to reduce the number of signatures a candidate must collect on a nominating petition from 100 to 50 & Revise Section 7.02 (b) to modify the window of time for a candidate to file a nomination petition with the Board of Elections from not less than 60 days before a regular municipal election to not less than 90 days before a regular municipal election.
